VII. Tuition

A tuition fee is required to cover materials, monthly program expenses, Eggs & Issues Breakfast, LHC Annual Retreat, graduation reception and plaque. VIII. Commitment

To graduate from Leadership Hall County, a participant is expected to attend *all* sessions.
